MINUTES (subject to agreement at the next Council meeting) of a meeting of the Parish Council held on Tuesday 11th February 2025 at 7.30pm in the Village Hall.

278. To receive apologies

Apologies were accepted from Cllr Harris

279. To receive declarations of interest/requests for dispensation

There were no declarations or requests

280. To receive and agree the minutes of the meetings held on 14th January 2025

The Minutes were agreed as a true record

281. Receive reports from Parish Councillors/Speed Watch Team/Clerk

Traffic Data – Community Speed Watch Team – A report was circulated confirming an increase in traffic volumes in 2024

Staffing Committee – Cllr Prince, Lennon, Torrington reported they were drawing up new staff contract

Village Hall – Cllr Prince reported the Gold Cup Café will go ahead this March and volunteers welcome

Footpath Warden – Cllr Sissons – reported trees down on footpaths being dealt with. Cotswold Wardens trying to track down landowner between Haymes and Gambles Lane to clear footpaths.

Cleeve Common Trust – Cllr Torrington/Harris – meeting due in March

282. Receive and request reports from the County/Borough Councillors

County Councillor David Gray reported that Gloucestershire was not chosen in the first round of devolved councils, but a decision on the make-up of the devolved authority needed by the end of March. 5 local MPs are keen on splitting the county. The County Council elections will go ahead but members will only sit for 2 years. The problem of utility companies careless use of road closed signs was being addressed. Cllr. Gray still trying to find solution to overnight vehicle stopovers in the laybys. He advised that TBC have given their councillors increases in their allowances. Discussions are taking place regarding CIL balances held by respective Borough Councils in the interim before devolution.

283. Adjournment for public participation on items on the agenda (*if about another subject residents should write to the clerk @southamtodayorg.uk*)

Cllr Sissons advised that members of the public have challenged the licence arrangements for events at the racecourse. Cheltenham Borough have consulted their residents with a closing date for comments by the 5th March. Southam Parish Council/residents not included in the consultation.

A member of the public advised he and a resident of Prestbury had been invited to take part in a Zoom conference call with the Wychwood Festival organisation. He asked that they review the way in which they monitor sound in Southam. They had indicated they were making changes to the location of the sound system (speakers). It was apparent in the discussion that a plan was always submitted to Cheltenham Borough Council but that this did not include any sound measurements taken from Southam.

A resident reported an unkempt willow fence on the path Ratcliff Lawns to the Church.

TBC has requested an extension to the 4th March and the statement of common ground will not be available as a basis for response by the Parish Council. The Council decided to assess the new information when available.
